### **TamilNadu Highlights**

#### Maternal Mortality in Tamil Nadu Drops to 39 – Public Health Department

- Tamil Nadu has reduced maternal deaths from **45 to 39**, according to the Public Health Department.
- A high-level medical team provides intensive care for severe complications during pregnancy and up to 47 days post-delivery.
- A list of government and private hospitals with full facilities for maternal care is shared with pregnant women a few months before delivery.
- Rural nurses continuously monitor pregnant women as part of this care program.
- Maternal mortality, which was 90 during the COVID period, dropped to 52, then 45, and now 39, thanks to early planning and regular monitoring.
- Infant mortality has also declined from 8 to 7 per 1,000 live births due to increased awareness and better healthcare services.

#### Kalaignar Kaivinai Thittam: Tamil Nadu's Inclusive Artisan Scheme

- Scheme Launch: CM M.K. Stalin launched Kalaignar Kaivinai Thittam, as an alternative to the Centre's PM Vishwakarma scheme.
- Inclusive Approach: The TN scheme allows artisans to choose from 25 trades, not just family-based ones.
- Eligibility & Support: Minimum age is 35 years, with loans from ₹50,000 to ₹3 lakh and subsidies included.



- Initial Response: 24,907 applications received; ₹170 crore sanctioned with ₹34 crore subsidy to 8,951 beneficiaries.
- Additional Announcements: Stalin announced enhanced GI tag subsidy, new infrastructure, and support for trade fairs.
- Micro Cluster Boost: He inaugurated three new MSME clusters and awarded top-performing units in the State.

# **National Highlights**

# Centre Notifies New Radar Speed Measurement Rules (Effective July 1, 2025)

- The Centre has amended the **Legal Metrology (General) Rules, 2011** to include new provisions for **radar equipment used in measuring vehicle speed**.
- All radar-based speed measurement devices must now be verified and stamped by Legal Metrology authorities for accuracy and compliance.

- The move aims to **enhance road safety**, ensure **fairness in traffic enforcement**, and **build public trust** in speed monitoring systems.
- The rules provide a **clear regulatory and technical framework**, aligning with **international** standards like **OIML R 91**.
- These radar devices, using **Doppler radar technology**, will offer **high-precision speed measurements**, ensuring reliable enforcement.

#### SECL Becomes First PSU to Use Paste Fill Technology in Underground Mining

- South Eastern Coalfields Limited (SECL) will be the first coal PSU in India to adopt paste fill technology in underground mining.
- A ₹7040 crore agreement was signed with **TMC Mineral Resources Pvt Ltd** to implement the method at the **Singhali mine** in Chhattisgarh.
- The mine will produce **8.4 million tonnes of coal over 25 years**, while enhancing safety and preventing **land subsidence**.
- Paste fill involves using industrial waste like fly ash and overburden, promoting environmental sustainability.
- This method is ideal for Singhali due to the presence of **surface infrastructure**, which makes traditional mining techniques unviable.

# Parappa Block in Kerala Wins PM's Excellence Award

• **Top Honour**: Parappa block in Kasaragod district, Kerala, won the *Prime Minister's Award for Excellence in Public Administration 2024*.

- Category: The award is under the Aspirational Blocks Programme category.
- National Recognition: Parappa secured the first position among 426 aspirational blocks across India.
- Award Ceremony: District Collector K. Inbasekar will receive the award in New Delhi on April 21.
- **Key Achievements**: The block excelled in *health, agriculture, tribal welfare,* and *entrepreneurship development*.
- **Inclusive Development**: Social welfare initiatives and participatory governance were also major contributors.

# CRPF to Set Up 11th CoBRA Battalion in Jammu & Kashmir for Anti-Terror Operations

- The Central Reserve Police Force (CRPF) is establishing its 11th CoBRA battalion to conduct anti-terror missions in forested and remote areas of Jammu and Kashmir.
- This move comes amid a recent surge in militant activity in the Jammu region.
- CoBRA (Commando Battalion for Resolute Action) is an elite CRPF unit specialized in jungle and guerrilla warfare, initially formed to counter Naxalite insurgency.
- The announcement was made by CRPF DG Gyanendra Pratap Singh during the 86th Raising Day in Neemuch, Madhya Pradesh.
- The new unit was formed following **Union Home Minister Amit Shah's directive**, expanding CRPF's operational strength in the region.

## **India Justice Report 2025**

**Initiated by:** Tata Trusts (with civil society and data partners) **Focus Areas:** 

- 4 Pillars: Police, Judiciary, Prisons, Legal Aid
- Parameters: Human Resources, Infrastructure, Workload, Budget, Diversity
- No State/UT met its own women police reservation quotas.



- Top Large/Mid-sized States: Karnataka, Andhra Pradesh, Telangana, Kerala, Tamil Nadu
- **Top Small State:** Sikkim
- Most Improved: Telangana (jumped from 11th to 3rd); Bihar (best improvement in police)

- Bottom Performers: West Bengal, UP, Uttarakhand, Jharkhand, Rajasthan
- Prison VC Facility: 86% of prisons equipped with video conferencing for trials
- Prison Overcrowding: 176 prisons operating at over 200% capacity
- **Delhi's Under-trials:** 91% of prison population
- Police-Population Ratio: 155 per 1 lakh people (vs sanctioned 197.5); 1 cop for every 831 people
- Women in Police: Bihar has the highest share; 78% of stations have Women Help Desks
- Budget Allocation (Per Capita):

Judiciary: ₹182

o Police: ₹1,275

#### **Judiciary & Case Disposal**

- High Court Disposal Rate: Over 100% consistently
- Subordinate Courts: Gradual improvement
- Judiciary Vacancies: HC 33%, District 21%
- No State allocates over 1% of its budget to Judiciary

#### **Prison Management**

- Tamil Nadu tops in prison governance: 100% budget utilization, higher allocations
- Caste segregation in prisons persists despite SC striking it down in 2024
- Low rehabilitation: Only 6% of inmates received education; 2% vocational training (2022)

#### Police & Infrastructure

- 17% police stations lack CCTVs
- 3 in 10 police stations lack women help desks
- 28% shortfall in officer-level positions

#### **Legal Aid & Paralegal Volunteers**

- PLVs down by 38% in 5 years
- Only 3 PLVs per lakh population
- PLVs are vital under the Legal Services Authorities Act, 1987

#### **Topic: Economy**

#### India's Pharma Exports in FY25 Cross \$30 Billion Mark

- India's pharma exports hit a **record \$30.47 billion** in FY25, exceeding the \$29.38 billion target.
- A **31.21% YoY surge** in March 2025 significantly contributed to the growth.
- Drug formulations and biologicals were top contributors at \$20.12 billion.
  The U.S. market alone accounted for \$8.95 billion, up 14.29%, with NAFTA region contributing 36.6% of exports.
- Despite global headwinds, exports to Africa, UAE, and China declined.
- Growth observed in **Ayush**, **surgical**, **and herbal products**, reflecting sectoral resilience.

#### **International Highlights**

#### U.S. Defends Steel and Aluminum Tariffs at WTO on National Security Grounds

- The **U.S. told the WTO** that its **tariffs on steel and aluminum** are based on **national security concerns**, not safeguard measures.
- India had sought consultations under the WTO's Safeguards Agreement, claiming the U.S. actions were safeguard measures.
- The U.S. countered that the tariffs were imposed under **Section 232** of its domestic law to tackle **national security risks**.
- It cited the national security exception under GATT 1994, arguing safeguard rules do not apply.
- India accused the U.S. of not notifying the **WTO's Safeguards Committee**, as is required for safeguard measures.
