- Third phase of excavation is ongoing

Gold Bell

- Depth: 2.04 meters
- Size: 6 mm (circumference), 4.7 mm (thickness)
- Weight: 22 mg

- Gold coin
- Pendant made of conch shell
- Agate stone ornaments
- Copper coins
- Terracotta figurine (broken)
- Chess game pieces Glass beads
- Round discs and conch bangles

- Established in 2018 by the Munril Literary Organization
- Honors Ma. Aranganathan, a distinguished literary figure
- Recognizes excellence in **poetry**, **short stories**, **novels**, **essays**, **plays**, **translations**, **research** works, literary criticism, and fine arts
- Two awardees are selected annually
- Includes a cash prize of ₹1 lakh for each recipient





National Highlights:

India's Renewable Energy & Power Sector Highlights (As of March 31, 2024)

Renewable Energy Growth:

- Total Renewable Energy Capacity: 2,109,655 MW (+14.77% growth from last year).
- Breakdown of Renewable Energy Sources:
 - Wind Power: 55.17% (Largest share).
 - Solar Energy: 35.5%.
 - Large Hydro: 6.32%.
 - Biomass, Bagasse-based Cogeneration & Small Hydro: Remaining portion.
- India's Global Renewable Ranking (IRENA 2024):
 - 4th in total renewable energy capacity.
 - 4th in wind power capacity.
 - 5th in solar power capacity.
- Target for 2030:
 - 500 GW of non-fossil energy capacity.
 - 50% of electricity needs from renewable sources.

Electricity Generation & Coal Dependency:

- Total Installed Electricity Generation Capacity: **521.31 GW** (+5.43% from 2023).
- Total Electricity Generation (FY 2023-24): 1,948,956 GWh (+6.5% from last year).
- Renewable Energy Contribution: 370,320 GWh (Up from 205,608 GWh in 2014-15).
- Coal Dependency:
 - Coal remains the dominant energy source.
 - Domestic coal production: 997.83 million tonnes (+11.71% growth).
 - Coal Reserves: **389.42 billion tonnes**.
 - Top Coal Reserve States: Odisha, Jharkhand, Chhattisgarh (≈70%).

Oil, Gas & Refining Sector:

- India's Refining Capacity: **256.82 million tonnes per year**.
- Operational Refineries: 23 (19 public sector, 4 private/joint ventures).
- Primary Energy Supply (FY 2023-24): 903.16 million tonnes of oil equivalent (+7.8% growth).
 - **Coal:** 60.21%.
 - **Crude Oil:** 29.83%.
 - Natural Gas: 6.99%.
- Reserves:
 - **Crude Oil:** 671.40 million tonnes.

• **Natural Gas:** 1,094.19 billion cubic meters.

Topic: Government Schemes and Initiatives

India's EV Sales & PM E-DRIVE Scheme (FY 2024-25)

- Milestone Achieved: One million EV sales in FY 2024-25.
- Aligns with: Net Zero by 2070 vision.
- Growth in EV Sales:
 - Electric 2-wheelers: 1,149,334 units sold (21% increase from last year).
 - Electric 3-wheelers: 159,235 units sold (57% increase).
- PM E-DRIVE Scheme (Introduced in September 2024):
 - Budget: ₹10,900 crore for two years (till March 31, 2026).
 - Merged with Electric Mobility Promotion Scheme 2024.
 - Encourages: Local EV manufacturing & ecosystem strengthening.
- Key Achievements under PM E-DRIVE (Till March 31, 2025):
 - Fuel saved per day: 8,55,723 litres.
 - Total fuel saved: 15,77,33,334 litres.
 - CO₂ reduction per day: 12,48,100 kg.
 - Total CO₂ reduction: 23,01,73,978 kg.

Topic: Polity

Protection of Interests in Aircraft Objects Bill, 2025

- Passed by Rajya Sabha on April 1, 2025.
- **Objective:** Implements international conventions on **aircraft leasing** to boost India's aviation leasing industry.

Current Scenario in India's Aviation Industry:

- Total aircraft in operation: 840.
- Leased aircraft share: 86.4%.
- Airlines depend on foreign leasing hubs like Ireland, Dubai, and Singapore.

Cape Town Convention, 2001 (Key Aspects):

- Provides legal protection for leasing high-value aviation equipment (aircraft, helicopters, engines).
- Strengthens rights of lessors (owners) & lessees (airline operators).

Topic: Reports and Indices

Sagarmala Programme – Progress Report

- Total planned projects: 839, worth ₹5.79 lakh crore.
- Completed projects: 272, worth ₹1.41 lakh crore.
- **Objective:** Port-led development using India's 7,500 km coastline and 14,500 km of navigable waterways.
- Key pillars:
 - **Port modernization** (103 completed projects, increasing cargo volumes to **528 million tonnes**).
 - Port connectivity.
 - Port-led industrialization.
 - Coastal community development (enhancing livelihoods, skill development, and economic opportunities).
 - Coastal shipping & inland water transport.
- Skill gap study conducted across 21 coastal districts in 9 states and 3 UTs, including Odisha & Tamil Nadu.
- DDU-GKY Sagarmala Convergence Programme:
 - MoU signed in 2017 between MoPSW & Ministry of Rural Development.
 - First phase (2016-2018): 2,079 candidates trained, 1,243 placed in jobs.

Education and Nutrition: Learn to Eat Well – UNESCO Report (March 27-28, 2024)

- Released during the Nutrition Development Summit hosted by France.
- Calls for governments to expand **school meal programs** and improve their **nutritional quality**.
- Key Findings:
 - In 2024, nearly 50% of primary school pupils globally received school meals.
 - 27% of school meals were not developed with nutritionist input.
 - Out of **187 countries**, only **93 had laws** or guidance on school food quality.





- Even fewer had **regulations on food sold** in cafeterias and vending machines.
- Impact of School Meals:
 - Enrollment rates ↑ 9%, Attendance ↑ 8%, and Learning improvement.
 - **Example:** Fortified organic pearl millet in Maharashtra, India, improved memory & attention span in adolescents.
- UNESCO's Recommendations:
 - Use fresh, locally produced foods.
 - Integrate **food education** into school curricula.
- Future Plans (2025):
 - UNESCO will develop a practical guide & training program for governments and education professionals.

Topic: Defense

INSV Tarini - Navika Sagar Parikrama II Expedition

- INSV Tarini reached Cape Town, South Africa, on March 31, 2025, completing the final phase of NSP II.
- Flagged off from Goa on October 2, 2024, by Admiral Dinesh K. Tripathi.
- Crew: Two women officers Lt. Cdr. Dilna K & Lt. Cdr. Roopa A.
- Roopa A.
 Covered: 23,400 nautical miles (~43,300 km) in 8 months, with stops at Fremantle (Australia), Lyttelton (New Zealand), Port Stanley (Falklands, UK), and Cape Town (South Africa).
- Expected return to Goa: May 2025.
- INSV Tarini: 56-ft-long indigenously built sailing vessel, inducted in 2018.
- Promotes women's empowerment in the Indian Navy.
- Navika Sagar Parikrama I (2017-18): First all-women crew circumnavigation, completed in 254 days.

India's Defence Exports – FY 2024-25

- Record-high defence exports of ₹23,622 crore, marking a 12.04% increase from ₹21,083 crore in FY 2023-24.
- Target: ₹50,000 crore in defence exports by 2029.
- DPSUs' exports grew by 42.85%, contributing ₹8,389 crore (up from ₹5,874 crore in FY 2023-24).
- Private sector exports remained steady at ₹15,233 crore (₹15,209 crore in FY 2023-24).
- Export authorizations issued: 1,762 (16.92% increase from 1,507 in the previous year).
- Total number of defence exporters increased by 17.4%.



Topic: Summit/Conference/Meetings

6th BIMSTEC Summit (April 3-4, 2025, Bangkok, Thailand)

- Theme: "Prosperous, Resilient, and Open BIMSTEC."
- PM Narendra Modi to attend the Summit on April 4 and hold a bilateral meeting with Thai PM Paetongtarn Shinawatra on April 3.
- Focus: Strengthening India-Thailand bilateral ties and economic partnerships.



- India-Thailand Trade & Investment:
 - 2023 trade: \$16.04 billion (India's exports: \$5.92 billion, imports: \$10.11 billion).
 - 2021: Thailand's biggest investment in India's renewable energy sector (\$453.29 million).
 - Thailand is India's 4th largest trading partner in ASEAN, after Singapore, Indonesia, and Malaysia.
- Previous BIMSTEC Summits:
 - 2004 (Bangkok), 2008 (New Delhi), 2014 (Nay Pyi Taw), 2018 (Kathmandu), 2022 (Colombo, virtual).

BIMSTEC It is an economic bloc that came into being in June 1997 through the Bangkok Declaration.

- BIMSTEC was initially formed with four member states- Bangladesh, India, Sri Lanka and Thailand on June 6, 1997.
- Nepal became an observer state in 1998 and became full-time member of the bloc along with Bhutan in February 2004.
- Members Bangladesh, India, Myanmar, Sri Lanka, Thailand, Nepal and Bhutan.
- o Permanent Secretariat Dhaka, Bangladesh



Topic: Important Days

World Autism Awareness Day 2025 – April 2

• **Established in 2007 by the UNGA** (Resolution A/RES/62/139) to promote autism awareness and advocate for the rights and inclusion of autistic individuals.

• From Awareness to Inclusion – Over 17 years, the focus has expanded from mere awareness to fostering acceptance, appreciation, and full societal participation of autistic individuals.

- 2025 Theme: "Advancing Neurodiversity and the UN Sustainable Development Goals (SDGs)"
 - Highlights how neurodiversity aligns with global sustainability efforts.
 - Promotes inclusive policies that support autistic individuals while contributing to the SDGs.
- Significance
 - Encourages recognition of autistic individuals' contributions to society.
 - Aims to create a more inclusive world through policy changes and advocacy.

International Highlights:

Japan to Grant Crypto Assets Legal Status as Financial Products

- Regulatory Shift: Japan's Financial Services Agency (FSA) plans to amend the Financial Instruments and Exchange Act to classify crypto assets as financial products.
- Stronger Oversight: The revision will introduce insider trading restrictions on cryptocurrency transactions and require detailed disclosures from businesses.
- Legislative Timeline: The FSA aims to submit the bill to parliament by 2026.
- Potential ETF Approval: Japan may lift the ban on crypto exchange-traded funds (ETFs), integrating digital assets further into its financial system.
- Investor Protection: The move aligns with Japan's tightening crypto regulations since legalizing Bitcoin as payment in **2017**, following hacking incidents and money laundering concerns.

Ruling on President Yoon Suk Yeol's Impeachment

- Impeached on: December 14, 2024, by the National Assembly of South Korea.
- Main Accusation: Declaring martial law without valid reason.
- Yoon's Defense: Martial law was a response to opposition's abuse of power, not an attempt at military rule.
- **Court's Ruling:** To remove Yoon, at least **six justices** must agree.
- If Removed: A new presidential election will be held within 60 days.
- Criminal Charges: Yoon is also accused of leading an insurrection.
